Dear Amrapali Home Buyer,

**Note: IN CASE OF SHIFTING/TRANSFER FROM ONE PROJECT TO ANOTHER VICE
VERSA BY AMRAPALI –NOTICE TO FILL IN DATA FOR SUBSTITUTION OF BUILDER
BUYER AGREEMENT/ ALLOTMENT.**

In the website facility to update details of transfer/shifting of Allotment from one Project to another or one Unit to another by Amrapali for issue of substitution to Agreement/Allotment for shifted/transferred Unit was informed to Home Buyers.

It is learnt from Home Buyers that they are in possession of Builder Buyer Agreement/ Allotment letter for existing Unit as issued by Amrapali, but they do not find Tower/Unit No. while uploading the data in the designated site for issue of substitution to the Agreement/Allotment letter for the shifted/transferred Flat/Unit. Due to this Home Buyers are unable to upload their data.

In order to remove the difficulties of the Home Buyers, the present site is updated with facility to enter such Tower/Unit No. via 'others' button. For example,-
